### ORDER:

In the Government order first read above, sanction had been accorded for Rs.1.00 Crore (Rupees One Crore) as 'Revolving Fund' for implementing the schemes of transportation of mortal remains of the deceased Non-Resident Tamils and for repatriation of Tamil Nationals in distress/medical invalidation.

2. In the reference second read above, Tmt. Susanna Chako George, Tmt. Pushpa Mary and Tmt. A. Jayanthi have represented that they had worked as staff nurse in Zawia hospital, Libya and stayed with their family members. In view of the war situation and life threatening, they were returned from Libya by spending their own money for Airfare as the Government of Libya and the Indian Mission in Libya were unable to extend any help to them. They have requested the Government to reimburse the airfare.

3. The Commissioner of Rehabilitation and welfare of Non-Resident Tamils had also forwarded the copy of the letter received from the Government of Kerala, NORKA (A) Department, wherein it has been stated that the airfare to the tune of Rs.18,77,030/- have been reimbursed to the six Keralitie families who returned from strife hit areas of Libya along with the three Tamil families stated in para-2 above. The Commissioner of Rehabilitation and Welfare of Non-Resident Tamils has furnished the following details:-
